Energy Bills Support Scheme	£400 per household	All households with a domestic energy meter are eligible, money to be paid via energy companies.  Direct debit and credit customers to have it credited to their account. Pre-payment meter customers paid via voucher or money applied to their meter.	Applied over six months from October 2022
Pensioner Cost of Living Payment	£300 per household	Those over State Pension age between 19 <sup>th</sup> to 25 <sup>th</sup> September 2022, and in receipt of Winter Fuel Payment.  Paid as an automatic top up to Winter Fuel Payment.	To be paid in November/December 2022

Cost of Living Payment	£650 per household, paid in two instalments	Households on certain means tested benefits on 25 <sup>th</sup> May 2022 for first payment. For the second payment, eligibility will be determined at a different date, TBC.  Paid by direct payment from DWP.	First instalment of £326 was paid from mid-July. Second instalment of £324 expected in October.
Disability Cost of Living Payment	£150 per claimant	Claimants on certain disability benefits are eligible. Payment direct from DWP.	Paid in September 2022
Council Tax Rebate	£150 per household	Most households in council tax bands A-D are eligible. Payment to be made by the Local Authority, automatically for those paying by Direct Debit, by application for those not.	To be paid from April 2022
