- 3. <u>Benefit Updates (Information from articles produced by Citizens Advice / CPAG /LASA / Benefits and Work updates summary)</u>

• Universal Credit (UC) communications

The DWP have become aware of fake text messages and an app called 'Universal Credit UK'. They are encouraging claimants not to use the app or respond to suspicious text messages while they work with their security teams to investigate.

- ✓ Case law Personal Independence Payment (PIP). Brief summaries and links to the judgments below.
 - "The pitfalls of elliptical extrapolation"

In some cases, you may find the DWP or a tribunal referring to a client's ability to complete one task as evidence that they are able to complete another, different, task. JM v Secretary of State for Work and Pensions adds to supportive case law that this can only be justified when the tasks are in fact directly comparable. You can find a copy of JM v Secretary of State for Work and Pensions: [2024] UKUT 283 (AAC) on GOV.UK.

Concessions before appeal

Sometimes the DWP will concede points should apply for certain activities post-mandatory reconsideration notice but pre-tribunal hearing. TL v Secretary of State for Work and Pensions says that where this happens, and both parties agree on the concession, the starting point for the first tier should be that these have ceased to become issues under appeal. You can find a copy of TL v Secretary of State for Work and Pensions [2024] UKUT 282 (AAC) on GOV.UK.

- ✓ RR v SSWP (UC) [2024] UKUT 261 (AAC) concerns whether an adult child who lives at home part of the time and at university part of the time counts as a non-dependent for a parent claiming housing costs under UC. The test is not determined by a crude measure of the time spent living at any one address. Decision makers and tribunals must make a holistic assessment of all relevant factors. The UT provides a non-exhaustive list of indicators that may aid in making this assessment.
- ✓ In <u>CB v SSWP [2024] UKUT 257 (AAC)</u>, the First-tier Tribunal (FtT considered revisions of **entitlement and recoverable overpayment decisions** made by the DWP in respect of 5 pension credit claims made from 2005 to 2020. The overpayments were found to result from misrepresentations by the claimant. The FtT erred in failing to explore whether evidence was in fact still available regarding the declarations made for the 2020 claim and considering whether to adjourn.

✓ <u>CD v SSWP (UC) [2024] UKUT 256 (</u>AAC)

finds that it is not discriminatory to award a bedroom for **UC housing costs to only one separated parent** for a child whose care is shared equally.

✓ LABOUR ADOPTS BANK SURVEILLANCE PLAN

Labour is to revive plans to force banks to carry out surveillance on claimants' accounts and give the DWP police type power to search premises and seize possessions. The *Fraud, Error and Debt Bill* will give the DWP: power to force banks and financial institutions to share data that may show indications of potential benefit overpayments, new powers of search and seizure, so the DWP can take greater control investigations into criminal gangs defrauding the taxpayer, power to recover debts from individuals who can pay money back but have avoided doing so. ✓ MORE PIP REVIEWS BUT FEWER ASSESSMENTS

The DWP have recruited additional PIP case managers and are now aiming to increase the number of PIP review decisions made without the need for the claimant to attend an assessment. The news underlines the importance of giving detailed information when making a fresh claim or a review claim Read More and Comment

✓ RECORD 3.5 MILLION PEOPLE NOW GETTING PIP

The latest PIP statistics show that at the end of July there were 3.5 million claimants entitled to PIP in England and Wales, a rise of 3% over the last quarter. 37% received the highest level of award, up from 36% in April. The success rate for new claims was: 46% for all new claims, this is identical to the same period last year, 53% for claims that got as far as assessment, an increase from 52% in July 2023, Most awards were very short, however: 79% were short term (0 to 2 years), 13% were longer term (over 2 years), 7% were ongoing Read More and Comment

✓ AUDIO RECORD YOUR WCA ON YOUR PHONE

Claimants have the right to audio record their work capability assessment for UC or ESA using their phone or other device.

✓ NEW PIP AND WCA ASSESSMENT COMPANIES

A new system for work capability assessments (WCA) and personal independence payment (PIP) assessments. The Health Assessment Advisory Service (HAAS) has taken over providing WCA and PIP assessments. HAAS is part of the DWP. It provides training, guidance and software for assessors. But the assessors themselves still work for private sector companies. There are four of these now involved in carrying out benefits assessments: Maximus, Capita, Serco and Ingeus. Read More and Comment

✓ ONE THIRD OF UC MIGRATION CLAIMANTS FAIL TO MAKE A SUCCESSFUL CLAIM

Statistics released in August by the DWP show that 32% of all claimants sent a UC migration notice failed to make a successful claim and had their legacy benefits terminated. In total 284,660 individuals did not make a valid claim and had their benefits stopped up to the end of February 2024.

✓ CLAIM AA ONLINE

The option to claim AA online has been quietly introduced by the DWP on their main AA page on gov.uk. A limited number of online applications now become available every Monday but, once they have all been used, no more are forthcoming until the following week. As well as scarcity, the new service seems to have a number of drawbacks, including: no obvious way to save a partly completed form; no way of submitting additional evidence online; no additional information boxes, just tick box responses for difficulties with a given activity. Readers applying for AA may want to stick to paper applications for now, unless the current online service is improved. Read More and Comment

✓ Migration to UC

The DWP is continuing to send notice letters to people on legacy benefits including Tax Credits. People claiming these benefits are being moved to Universal Credit- If your client has received a Universal Credit migration notice letter, make sure they understand the deadline that has been provided. Here are important things to know about deadlines: The deadline to migrate to Universal Credit will be three months after the date the notice letter was sent, their legacy benefits will stop after this deadline, Make a successful claim for Universal Credit by the deadline The timing of that claim can be important so that they can prevent gaps between claims

From July to November 2024, people over State Pension age who get Tax Credits will start receiving letters from the DWP or HMRC. These letters will tell your client to apply to either <u>Universal Credit</u> or <u>Pension Credit</u>. They will receive either a 'migration notice' with the date they need to apply for Universal Credit or a 'tax credit closure notice' with the date they need to apply for Pension Credit by. **It's very** important that they apply for Universal Credit or Pension Credit by the date in

their notice letter. If they don't, they could lose transitional protection, which is extra money added to their benefit

✓ Education Maintenance Allowance (EMA) and University Bursary schemes

You can apply for EMA or a University bursary until 11 November 2024. Education Maintenance Allowance allows pupils in Sixth Form schools and colleges to apply for £600 to support them with their studies. Eligibility for EMA: Between 16 and 19 years old on 1 September 2024, on a full time study programme at a recognised sixth form provision/college, household annual income (excluding Housing benefit and Council tax reduction) needs to be below £25,000, a resident of Tower Hamlets for three years unless you are a refugee on the Ukraine or Afghan scheme, need at least a 95% attendance record at the end of your first term https://www.towerhamlets.gov.uk/lgnl/education_and_learning/school_finance_and_support/EMA-and-University-Bursary-awards/EMA-and-University-Bursary.aspx
