#### Direct right of appeal against tax credit decisions

New regulations, with effect from 27 December 2024, clarify that there is a direct right of appeal to a Tribunal against a tax credit decision (without the need for a mandatory reconsideration to have been done first), bringing into effect the findings of the Court of Appeal in the case of <a href="https://example.com/hmrc/hmrc/mr/>hmrc/y/Arrbab/2024] EWCA Civ 16</a>.

#### Bone anchored hearing aid is an 'aid' for the purposes of PIP

In AB v SSWP [2024] UKUT 376 (AAC), the claimant had a bone anchored hearing aid (BAHA), consisting of both an internal implant and an external part. A First tier Tribunal refused points for activity 7 'Communicating verbally', finding that the implant enabled the claimant to hear and so he did not require the use of an 'aid'. The Upper Tribunal allowed the claimant's appeal and awarded an additional 2 points for the descriptor. Whilst the internal part of the BAHA could be viewed as an implant, the device would only work with the additional use of the external part, and so that was an 'aid' which improved the claimant's hearing. The Judge also gives an opinion that cochlear implants (which also have an internal and external part) should be treated the same way

#### DWP MELTDOWN SPREADS TO PIP MRs

PIP mandatory reconsiderations are now taking almost twice as long as they did a year ago, up from 37 days to 71 days. In the full article, we've listed some of the many other signs that the DWP doesn't have enough employees to cope with its workload. This includes:

#### LATEST WCA STATISTICS FOR ESA AND UC

The latest WCA statistics - ESA, 67% of new claimants placed in the support group and 14% in the work-related activity group, with the remaining 19% found fit for work. For UC, 64% of new claimants were placed in the limited capability for work-related activity group and 16% in the limited capability for work group, with the remaining 20% found fit for work. At least 69% of applicants are recorded as having mental and behavioural disorders, although this may not be their primary medical condition. Whilst 53% of those found fit for work had mental and behavioural disorders, fully 90% of those awarded benefit had these conditions. Read More and Comment

#### ESA MIGRATION FIT NOTE PROBLEM ALLEGEDLY FIXED

The DWP claims to have applied a 'fix' to the problem of ESA) claimants who are migrated to UC being unlawfully asked to provide fit notes. There have been many instances of work coaches demanding fit notes as well as trying to impose work-related requirements on former support group members during claimant commitment meetings. On 16 October Neil Couling, the head of the DWP's UC team admitted on X that the DWP were getting it wrong and that a "tactical fix" would soon be applied, followed by a full system fix. #### Payments for the loss of the enhanced disability premium

Regulations to provide transitional protection for some Universal Credit (UC) claimants who received the enhanced disability premium on migrating to UC came into force on 14 February 2024. These additional payments are due to the High Court decision in TP and AR (TP and AR No. 3) ([2022] EWHC 123 Admin. Many affected claimants have still not received these additional payments. In response to a written parliamentary question, the Secretary of State for Social Security has stated that: 'monthly payments are expected to commence in a controlled manner in Quarter 1 of 2025, subject to payment accuracy assurances being satisfied.'

#### • GD v SSWP [2024] UKUT 407 (AAC)

In <u>GD v SSWP</u> the upper tribunal (UT) considered the correct approach to establishing the speed of walking for activity 2 of the personal independence payment (PIP) mobility component - moving around. Under <u>regulation 4(A) SS(PIP) regulations 2013</u> a claimant needs to be able to complete the activity within a reasonable time period and to an acceptable standard. The UT concluded that these provisions require a tribunal to consider both time and distance together to establish the speed of walking. The first-tier tribunal (FTT) had erred in law by failing to make adequate findings on this issue. The FTT had either: considered neither of these issues or only considered time or distance separately. The UT also pointed out that if the FTT did not have enough evidence to determine walking speed they should have considered adjourning the hearing to allow the claimant to give evidence in person, as the case was decided on the papers only.

#### • KW v SSWP [2024] UKUT 410 (AAC)

In <u>KW v SSWP</u> the UT considered activity 9 of the PIP daily living component - engaging with other people face to face. The FFT had made assumptions about the claimant's ability to perform this activity based on evidence about their employment. The UT allowed the claimant's appeal on the grounds that the FTT failed to make sufficient findings to determine whether the claimant was able to undertake this activity in a 'contextually and socially/appropriate manner and had the ability to establish relationships independently'. This is consistent with other case law which makes it clear that the claimant must be able to complete this PIP activity in a wide range of social settings.
