- 3. Benefit Updates (Information from articles produced by Citizens Advice / CPAG /LASA / Benefits and Work updates summary
 - ✓ DWP confident that delays in paying the Limited Capability for Work Related Activity (LCWRA) element in UC have ended

Citizens Advice and others highlighted a problem with claimants not receiving the LCWRA element by the end of their first assessment period. DWP has now acknowledged that this should not happen and taken remedial steps to ensure that payments will be made following the first assessment period. They've put additional resources in place, implemented checks earlier in the process and are working to increase the number of claimants who can have their identification verified by phone rather than at an in-person meeting.

DWP has said it is confident that the backlog of cases that contributed to the delay has been cleared, but encourages anyone still experiencing delays to bring them to their attention using the usual escalation routes.

✓ Upper tribunal decides that tribunal erred by not considering whether earplugs could be an aid for Personal Independence Payment (PIP)

In <u>KW v Secretary of State for Work and Pensions UA-2025-000283-PIP</u> the claimant had several conditions including autism spectrum disorder (ASD), a personality disorder and hyperacusis, a condition where everyday sounds are perceived as uncomfortably loud

or painful. He claimed a need to wear earplugs so that he could cook and wash himself. The tribunal did not award points for needing to use an aid for daily living activities and awarded only 2 points for engaging with other people. The upper tribunal allowed the appeal and set aside the decision. The decision involved multiple errors of law, including about the appellant's use of earplugs. As he has to wear earplugs to carry out the activity of cooking and washing, it was unclear why no points were awarded for requiring an aid. The tribunal failed to address this in their reasons and did not make findings of fact about the level of pain that the appellant experienced while cooking and bathing as a result of noise. The Judge also found that it erred when deciding to award only 2 points under activity 9 - engaging with other people, because he did not have a diagnosed mental health condition

5. Vacancies

✓ Law Students – Qualifying Work Experience Volunteer Project

From September 2025, the Island Advice Centre in collaboration with University House will be offering a limited number of 6-month internships to law graduates.

These internships will accrue valuable Qualifying Work Experience (QWE) and will be signed off by one of the University House project solicitors.

Our partnership are not-for-profit legal advice providers. Internships will be offered in single subjects only, covering Welfare Benefits or housing.

You would have to commit for a minimum of 2 days per week as a volunteer, but the more hours you do the greater the QWE you will accrue.

As well as meeting QWE relevant to qualifying as a solicitor, our internships will also serve as an important introduction to the not-for-profit legal advice sector

Work will involve interviewing clients, assisting with welfare rights and housing enquiries, doing follow-up letters and casework.

Travel expense of £7 per day and lunch expense of £4 per day will be re-imbursed upon receipt All the work is supervised and there are some training sessions available.

To qualify for one of these internships,

- Be a graduate in Law.
- You must be available for 2 full-day per week minimum for a minimum of 6 months.
