3. <u>Benefit Updates (Information from articles produced by Citizens</u> Advice / CPAG /LASA / Benefits and Work updates summary

> Child Benefit Extension

If your client's child is 16 or over and staying in full-time education or approved training, they will need to tell HMRC by **31 August 2025** to continue getting Child Benefit payments. If they don't their Child Benefit will stop. They can extend their claim online using the GOV.UK website, or on the HMRC app.

➤ State Pension Age Letter If your client was born between 6 April 1961 and 5 April 1962, the DWP will be writing to them soon. The letter will confirm that their State Pension age is 67. This is because the State Pension age is increasing from April 2026. The DWP will be sending letters to people to highlight the change and provide information on how to check their state pension forecast. Your can check your client's pension age and get a pension forecast by <u>using the</u> government's online tool. For more information, <u>read our State Pension age changes guide</u>.

> Issues moving to UC for ESA Claimants

Some people who have moved from ESA to Universal Credit through the managed migration process have noticed that their LCW or LCWRA element is missing from their first Universal Credit assessment. Without the LCW or LCWRA included, your client's first payment may be lower than expected. The DWP has said that it is automatically making payments to people who have been missing these elements. Your clients won't have to wait until their next assessment period. The DWP will leave a message in your client's journal telling them that they've been paid. If your clients are effected by this situation try the Turn2us Grants Search to find a charitable grant to help cover the cost.

> Transitional Element

If your client's Universal Credit income is less than the benefits they received under the old benefits system, they could be entitled to a transitional element, which is paid on top of their Universal Credit, to ensure that they are not worse off in the short-term. To get the transitional element they must have received a Migration Notice and claimed Universal Credit within the deadline stated in their notice letter. We estimate the amount of transitional element on the Turn2us Benefits Calculator where it applies. The transitional element will decrease over time and there are situations where it can be removed all together.

> New legislation - evacuated or advised to leave

In force from 18 July, new regulations exempt certain cohorts from the habitual residence test (HRT) and past presence test (PPT) where the government has advised British nationals to leave a territory or arranged their evacuation. They also allow for temporary absences where claimants were in the country/territory before the advice to leave was given and it is deemed that returning would have been unreasonable. The stated aim is to provide a blanket approach so the government doesn't have to lay new law whenever a crisis emerges. Severe Disability Premium (SDP) Transitional element compensation

In 2024 the government enhanced transitional protection for those who had lost their premiums migrating to UC. This applies to those previously entitled to an enhanced disability premium, disability premium, disabled child premium or disabled child element as well as the SDP. Payments arising from that law are exempt from income tax but the government also brought in separate compensation for those eligible before the law was introduced. Legislation has now exempted those compensation payments from income tax too, with retrospective effect to payments received from 18 December 2024. Changes to Child Benefit (CB)

From September 2025 Child Benefit eligibility is being expanded. The definition of full-time education will include education of less than 12 hours per week for those who suffer 'from an illness or physical or mental disability' for 'any amount of hours appropriate for that person's individual circumstances'. It will also no longer be a requirement, where education is provided outside a school or college, that the education began before the young person turned 16 (as it does now, with limited exceptions). LATEST ON UC AND PIP BILL AS LABOUR GETS THROUGH THIRD READING

The Labour government has got its severely weakened welfare bill through its third reading without further defeats, after the major concessions made before and during the second reading. 47 Labour MPs voted against the bill at third reading, compared with the second reading where 49 Labour MPs voted against. The chamber was largely empty as a large number of amendments were debated, only filling up for the votes. All the government amendments to the bill, including the promise to remove clause 5, the 4-point rule clause, were agreed. Every non-government amendment failed, except for one relating to co-production of the Timms review, which was withdrawn after concessions from the government. Updates on the Universal Credit (UC) and Personal Independence Payment (PIP) Bill

The UC and PIP Bill passed its second reading in the House of Commons on 1 July. However, the government announced significant changes to the bill, and has tabled these as amendments which will be voted on this week. The changes to PIP eligibility conditions (the proposed 4-point rule) will be removed from the bill and revisited in a review in Autumn 2026. There won't be any changes to PIP eligibility in the legislation currently going through parliament. The review plans to consider the assessment criteria for both components, and the role of the PIP assessment as a future single gateway to health and disability benefits.

In relation to UC, the bill will increase the standard allowance above inflation in the tax years from 2026/27 to 2029/30. It will reduce the limited capability for work and work-related activity (LCWRA) element from £423.27 to £217.26, at current rates, for most new claimants from April 2026. Claimants who already have LCWRA, and some new claimants meeting severe conditions criteria, will continue to get the higher rate. The LCWRA element will be frozen from 2026/27 to 2029/30, but for those still getting the higher rate it will be uprated where there is a shortfall following the increase to the standard allowance.


